- WHEREAS, the Rosebud Sioux Tribe is federally recognized Indian tribe organized pursuant to the Indian Reorganization Act of 1934 and all pertinent amendments thereof,
- WHEREAS, the Rosebud Sioux Tribe is governed by a Tribal Council made up of elected representatives who act in accordance with powers granted to it by its Constitution and By Laws, and
- WHEREAS, the Rosebud Sioux Tribal Council established the Rosebud Sioux Tribe Election Board pursuant to Article IV, Section 1 (u) of the Constitution and By Laws of the Rosebud Sioux Tribe, and
- WHEREAS, the Rosebud Sioux Tribe Election Board has reviewed the Rosebud Sioux Tribe Election Code, Ordinance 86-10 and has developed proposed amendments to the Election Code, and
- WHEREAS, the proposed amendments were developed to ensure that all tribal elections governed by the RST Election Code, Ordinance 86-10 are fair and conducted with all procedural requirements set forth in the code, and
- WHEREAS, the RST Election Board acting under their subject matter jurisdiction did approve and submitted the amended RST Election Code, Ordinance 86-10 to the RST Governmental Affairs Committee for their perusal and recommendation to the RST Council for approval, now

THREFORE BE IT RESOLVED, the Rosebud Sioux Tribal Council accepts the recommendation of Rosebud Sioux Tribal Election Board and RST Governmental Affairs Committee and hereby adopts the amendments to the Rosebud Sioux Tribe Election Code, Ordinance 86-10.
